The Equity in Athletics Disclosure Act (EADA) report is an annual document mandated by the U.S. Department of Education to ensure transparency in gender equity within collegiate athletics. This report provides a comprehensive overview of Texas Lutheran University's athletic programs for the 2023-2024 academic year, including participation rates, financial allocations, staffing, and resource distribution between men's and women's teams.
