Teacher candidates enroll in a course specific to teaching students with special needs and a course focused on strategies for teaching ESL students. As part of each course, they do ~10 clock hours of field work in public school classrooms that serve students with special needs and ESL. This field work may include basic observations, one-on-one tutoring, and whole class instruction. Since our university is located in a rural/suburban area, teacher candidates automatically have field experience in rural and suburban schools.

Students have numerous campus-based computers with a variety of software, printing possibilities, and other technological devices.

Many of our courses include preparing our teachers to teach diverse student populations include students with disabilities. Our pre-service teachers take a course titled Teaching Special Population which focuses on IDEA, 504, and differentiation.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Students learn the requirements of IDEA and 504 plans in their Teaching Special Populations coursework. During their student teaching our students may participate as a member of an IEP team.

Many of our courses include teaching students who are limited English proficient. All pre-service teachers take at least one literacy based course and teaching ESL or LEP students is a part of this class. Our students can also choose to take two ESL specific courses as well as the ESL supplemental test. We also make sure our students know that many Texas school districts now require the ESL supplemental test within one year of being hired no matter what content area they are teaching.
